Continuing professional development is part of good professional practice. To support the broadening of scope of education, in line with changing landscape, FPAM has increased its list of Continuing Education Activities.

WHAT IS NEW?

- Increase in list of activities
- Change in requirements from bi-annually to annually
- Annual requirement effective 2018 is 20 points per calendar year

REVISION IN FPAM CE POINTS AND ACTIVITIES **EFFECTIVE 2018**

Comparison and Purpose of Revision

Associate Members of FPAM are required to complete 20 CE points every 2 years	Associate Members of FPAM are required to complete 15 CE points per calendar year	<ul style="list-style-type: none"> To broaden the scope for continuing professional development To streamline the monitoring of continuing education requirements To facilitate the implementation of online CE monitoring.
Certified Members are required to complete 30 CE points every 2 years	Certified Members are required to complete 20 CE points per calendar year	<ul style="list-style-type: none"> Provided avenues for outstation members to accumulate points by participating in the local chapter activities.

Biennial points 2016-2017 for 2018 recertification	Ensure you have 20 CE points from 2016-2017 by 31.12.2017	Ensure you have 30 CE points from 2016-2017 by 31.12.2017
2018 points for 2019 recertification	Ensure you have 15 CE points by 31.12.2018	Ensure you have 20 CE points by 31.12.2018
Gentle reminder:	Annual subscription of 4E Journal is 5 CE points which is included when you recertify.

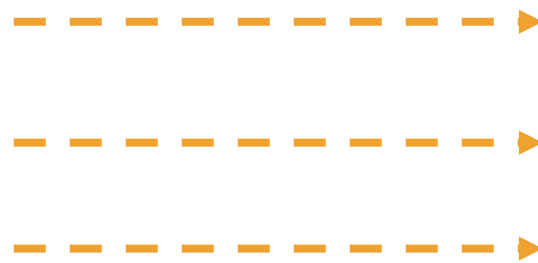
